This Guarantee is an absolute, unconditional and continuing Guarantee of payment as set forth herein and all substitutions or replacements thereof.

Seller may at any time and from time to time, without the undersigned's consent, and without affecting or impairing the obligation of any of the undersigned hereunder, take any action with respect to, or waive or amend any of the obligations of the Customer, including without limitation, any of the following: (i) renew or extend any obligations of Customer or of co-guarantors (whether hereunder or under a separate instrument) or of any other party at any time directly or contingently liable for the payment of said obligations without limit as to the number or extent of said obligations; (ii) accept partial payment of said obligations; (iii) settle, release (by operation of law or otherwise), compound, compromise, collect or liquidate any of said obligations and the security or collateral therefore, if any, in any manner; or (iv) consent to the transfer of, or release from time to time, security or collateral, if any.
